5. AB 2449	Susy Marrón shared about changes related to the		
	Brown Act which will take effect January 1, 2023. AB		
	2449 becomes law January 1, 2023 and the California		
	state of emergency will end February 8, 2023. This		
	means that provisions of AB 361 will no longer apply		
	and meetings will need to be held in person beginning		
	March 1, 2023. Under AB 2449, a teleconferencing		
	option will need to provided to members of the public		
	effective March 1, 2023.		
	Sonya Valiente asked how many members will need		
	to attend meetings in person. Susy Marrón shared		
	that all members will be expected to attend in		
	person, while guests will be able to join the meeting		
	virtually under AB 2449.		
	Jessica Borland commented that in the education		
	field many people have been contracting illnesses and		
	she is concerned that we may not be able to meet		
	quorum due to members needing to cover staff shifts		
	instead of attending meetings.		
	Susy shared that all standing committee meetings		
	which are required to follow Brown Act will need to		
	be held in person while workgroups and ad hoc		
	groups will be able to continue to meet virtually.

	able to attend due to a staffing shortage or other reason. Susy Marrón answered that the "just cause" provision is only able to be utilized once per year per member. Susy described an alternative where CCPC can revert to traditional Brown Act which would require a quorum in person, but would allow additional members attend meetings virtually. The challenge may be that members attending meetings virtually would be required to post their location publicly and allow members of the public to enter and attend meetings from their location. Lara Magnusdottir asked if it would be helpful to hold meetings at a more central location like the 4Cs office. Susy shared that it would be a possibility to hold meetings at a location other than SCOE and this is something that CCPC has done in the past. Jessica Borland asked if the meeting could be split between two locations. Susy Marrón shared that she believes quorum is required to be in one location, but she will confirm to be sure.

8. Child Care Plan Overview & Breakout Sessions	Susy Marrón shared that the Child Care Plan has been approved and the final version will be submitted to the County Board of Supervisors at an upcoming meeting. Susy Marrón read the 4 goals outlined in the Child Care Plan. Susy described SMART Goals and asked that members keep them in mind as they think about and discuss the Child Care Plan. Susy described how the goals in the Child Care Plan are organized. Participants were prompted with the question, "What are your initial reactions to the goals, strategies and key measurements?" Susy Marrón invited participants to share about what they discussed in the breakout sessions. Jessica Borland shared that her group discussed after care for TK and Kindergarten children and staffing issues. They also discussed making sure all children are thriving and considered the experience of TK children in the elementary setting.	Participants were invited to join breakout rooms. 	current programs are only a band aid solution. They		
	see the facilities problem as an equity issue. Leslie		
	suggested that funding and support from many		
	members like a community bank, chamber of		
	commerce and other community organizations would		
	be needed. Leslie and Bryan brainstormed how CCPC		
	can support the process.
