6. CCPC Programs:	Susy, Erica and Liz presented the annual CCPC		The CCPC Programs report is

	During the section on the Shared Services Agreement		
	(SSA), Lara asked what the funding which is not		
	included in CCPCs annual budget is being used for.		
	Susy explained that funding is divided between CCPC		
	and First 5 and that the funding supports training and		
	technology needs for participants. Kathy asked how		
	this project may connect with 4Cs CCIP program,		
	River to Coast Resource and Referral Agency and		
	Children and Family Circle. Susy shared that they

	utilized information from those agencies in order to		
	identify and recruit potential participants for the		
	program. Kathy shared that she thinks it would be		
	helpful to gather information from participants to find		
	out how many children they serve and how long		
	participants stay in the field. Susy shared that there		
	are plans to provide opportunity for a pre and post		

	assessment of the program. Susy also agreed that it would be wonderful to find out the longer term effects of the program. Leslie Corral Cisneros from First 5 shared that she is co-facilitating the SSA. She shared that some of the funding will go toward hiring subcontractors such as the Small Business Development Center, as well as trainers and consultants to work with mentors and providers dependent upon their needs for professional development. Leslie shared that there are talks within First 5 about potentially extending the program. During the section on the QCC / CSPP Block Grant: Kathy asked if Susy can find out if the Teaching Pyramid Observation Tool (TPOT) may be included as an assessment tool. Susy agreed that she will look into that.		
7. Executive Committee Report	Susan shared that the Our Kids Our Future measure did not make it onto the November ballot. The Executive Committee agreed that they would not recommend supporting the measure at this time. The committee would like to revisit the option to support the measure at a later date when more information is available. Susy thanked those who gave feedback through the previous feedback forms. Susy shared that workgroups struggled to make time to meet last year, likely due to staffing shortages and other challenges. For this reason, workgroups will not be responsible for Hot Topics in the coming year, but rather, members and guests can make suggestions for Hot Topics.	Erica shared a link to the Co- Chair nomination form in the chat box	

	Susan encouraged members and guests to complete the member survey and shared that it, in her experience, has been an effective way to make suggestions and share opinions. Susy encouraged CCPC members who may be interested in the CCPC Chair-Elect position to complete the nomination form.	
8. Coordinator Report	Susy shared that, as of this year, Local Planning Council (LPC) funding will be doubled and restored to the levels they were at before funding was cut during the recession. This is ongoing funding. Susy shared that the state budget includes \$55 million over three years which will go to LPCs to support Universal PreKindergarten implementation. Lara added that this funding was meant to be an accompaniment to SB 976, the Universal Preschool Act, which was unsuccessful. Lara shared hopes that a similar bill may be successful in the future which would help to create a cohort of supporters of UPK implementation from the early learning and care community. Susy shared that once more details are available about the funding, this council will have the opportunity to discuss options and possibilities for the funding.	
9. Child Care Consumers/Child Care Providers Input/Member Announcements	Rebecca shared that Bright Futures preschools has partnered with South County Consortium to create an inclusive program. She also shared that Kids Care is hiring. Susan asked if Kids Care can take volunteers. Rebecca confirmed that yes, they can take volunteers.	

10. Public Announcements	Renee shared her opinion that the Early Learners Conference would be a positive event for the ELC community in the coming year. Missy shared that she has been in conversation with Alice and has plans to reach out to the planning committee to get things going. Renee encouraged people to participate in the planning committee. Susan volunteered to participate in the planning committee. Kathy shared that her Teaching Pyramid cohort has 110 participants in the Sonoma County series for this year in addition to a Sonoma Valley cohort of 20 participants. She thanked everyone who is involved and participating. Brulene shared that SCOE is involved in a pilot program to bring Teaching Pyramid to TK teachers in Sonoma County. She is working with CRPUSD, SRCS and Wright School District. Lisa Stienman shared that she has the ability to provide presentations to the community on lead risks and precautions, a team of home visitors to assess risk, and other resources. Sonya asked if this program is related to the water testing of child care centers. Lisa answered that that is a separate program, but her program is able to provide resources and training for early learning and care programs. Lisa invited people to reach out to her for more information.	Lisa shared information on her program as well as contact information in the chat box.
