| SCOE Screening Procedures<br><b>SP</b>   | Revised protocol started today. Due to the latest rises in numbers, staff are trying to be very careful. The question is what will the screening protocol be for staff arriving before the nurse, or if they come in through a different entrance. Department leads should be discussing with their staff about what the questions are. If people get here early, it will be a self assessment based on the questions that are shared out from Administration. There are two types of cases: community spread and work/school spread. To date SCOE doesn't have any work spread cases. The main thing holding us from reoccupation, is the ICU bed availability. The note to be entering through the front door at the beginning of your work shift, will be shared again through SCOE Announcements.   |
| School Reopening, Program Transfers and Class Closures for SpecEd<br><b>MC</b> | There was a meeting with the Community Advisory and Ms. Corbin will be in a meeting next week with parents directly impacted by the SRCS transfers.. There is a Program Transfer meeting on 1/26 at 2:00 p.m. The final number of layoffs has not been determined yet. We have 5 TA vacancies, so as we approach the end of the year, those are 5 less layoffs. It will be a reduction from 7-10 classes. We are presently 39 students under budget. We've picked up no new students and have lost students from our programs. If people are certain they will be retiring, letting us know sooner than later, reduces the number of people who receive a layoff notice. There will not be a Golden Handshake this year. However, if SCOE is given notice of a retirement by March 1, 2021, then we can extend SCOE's portion of health care contribution through the summer. |
