Check with Human Resources or attorneys regarding wording of Article V: Meetings, A. Regular Meeting of the CCPC, paragraph 2 "Meetings shall not be held in a facility that prohibits the admittance of any person on the basis of ancestry or any characteristic listed in Government Code §§54950 et seq.) on page 5 not limited to religion, "gender identity" instead of "sex", or sexual orientation. Or should "gender identity" be added to the list?
Recommend Hot Topic for November, having QRIS assessors come to a Council meeting and tell us what they're seeing in the field. Susy will check with First5 to see if they'll present in November also.
7. Membership Committee Logic Model for 2019/2020: The Committee will do a survey monkey to ask members why they're here, what other boards they are serving on, and what their motivation is to attend. Patty will help develop a tool to survey members; needs and interest, what they want to contribute, etc. We'll also develop an organizational chart/Board of Supervisors flow chart.
