## **Removing Barriers to Online Enrollment for Students Experiencing Homelessness**

As families within our districts attempt to enroll through online systems; experiencing homelessness struggle with limited access to technology and connectivity, as well as basic enrollment barriers such as lack of information about the McKinney-Vento Act, lack of a pathway to enroll without documents, and inaccessible language. Students and families for whom English is not their first language, and those unfamiliar with online platforms and processes, will be disproportionately impacted by these barriers. The documentation attached below is to help break down the barriers and serve our families to the best of our ability.
